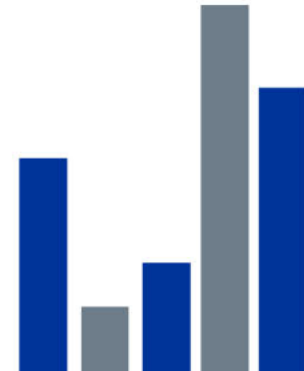

Programa aprobado: 3.06.2015

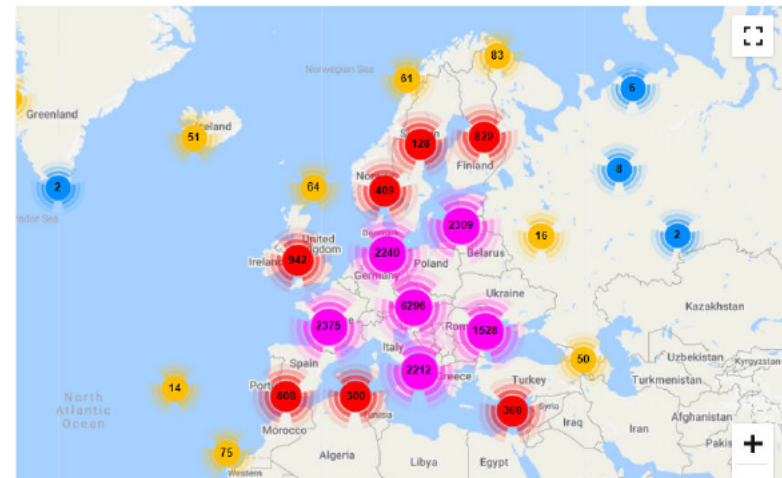

INTERREG - European Territorial Cooperation 5 objectives will drive EU investment in 2021-2027



1. **Smarter Europe**, through innovation, digitisation, economic transformation and support to small and medium-sized businesses
2. **A Greener, carbon free Europe**, implementing the Paris Agreement and investing in energy transition, renewables and the fight against climate change
3. **A more Connected Europe**, with strategic transport and digital networks
4. **A more Social Europe**, delivering on the European Pillar of Social Rights and supporting quality employment, education, skills, social inclusion and equal access to healthcare
5. **Europe closer to citizens**, by supporting locally-led development strategies and sustainable urban development across the EU.

EU FUNDING CONTRIBUTION

Under the Interreg Europe Programme 2014-2020, the project activities were co-financed by the **ERDF (European Regional Development Fund)** – one of the European Structural Funds).

75% (private non-profit bodies from EU Member States) + **85%** (public bodies and bodies governed by public law from EU Member States).



WHO CAN ACCESS FUNDING?

Public organisation and non-profit entities | SMEs cannot directly receive EU funding as a beneficiary.

HOW MANY PARTNERS FROM HOW MANY COUNTRIES?

At least 3 countries, of which at least 2 partners must be from EU Member States.

5 to 10 partners appear to be the best configuration to ensure efficient interregional learning.

Policy Objective 1: Smarter Europe

- (i) enhancing research and innovation capacities and the uptake of advanced technologies;
- (ii) reaping the benefits of digitisation for citizens, companies and governments;
- (iii) enhancing growth and competitiveness of SMEs and job creation in SMEs;
- (iv) developing skills for smart specialisation, industrial transition and entrepreneurship;

Policy Objective 2: Greener Europe

- (i) promoting energy efficiency measures;
- (ii) promoting renewable energy;
- (iii) developing smart energy systems, grids and storage at local level;
- (iv) promoting climate change adaptation, risk prevention and disaster resilience;
- (v) promoting sustainable water management;
- (vi) promoting the transition to a circular economy;
- (vii) enhancing biodiversity, green infrastructure in the urban environment, and reducing pollution;

Policy Objective 3: More connected Europe

- (iv) promoting sustainable multimodal urban mobility;

Interreg Atlantic Area Transnational Cooperation Programme 2014-2020

Transnational Cooperation area among: 36 Atlantic regions of 5 European countries (France, Ireland, Portugal, Spain and United Kingdom), contributing to the achievement of economic, social and territorial cohesion.

Total budget of the Programme: 185 M€ (being 140 M€ of ERDF – European Regional Development Fund to co-finance projects up to 75% of their total budget, for public & private entities).

What is an “IVY experience” about?

The [Interreg Volunteer Youth](#) (IVY) is part of the broader [European Solidarity Corps Initiative](#) launched by the European Commission and announced by President Juncker on 14 September 2016, which aim is to boost and enhance values such as sense of **solidarity cooperation**, **European citizenship** and **civic engagement among young people**.

IVY gives volunteers the opportunity to acquire a unique experience of **personal growth** as well as enhancing and **gaining skills that they can employ in their future** experiences.

How? By allowing young people to **familiarise with European Territorial Cooperation** (also known as “Interreg”) and other programmes and projects of cooperation. Through their **volunteering experience**, young people **grow aware of the many benefits of collaboration among regions within the EU and with its neighbours**.

Who is eligible to participate in IVY?

IVY offers the possibility to **young people aged 18-30** to serve as volunteers in **cross-border, transnational or interregional programmes** and related projects.

If you are younger than **31 and older 18**, and you come **from a European Country** or its partner countries, you can become an **IVY volunteer**.

“Partner countries”: Albania, Algeria, Armenia, Belarus, Bosnia and Herzegovina, Egypt, North Macedonia, Georgia, Iceland, Israel, Lebanon, Liechtenstein, Montenegro, Norway, Palestine, Republic of Moldova, Russia, Serbia, Switzerland, Tunisia, Turkey and Ukraine.
